The undersigned Guarantor(s) waives notice of any of the foregoing changes. The undersigned hereby waives any and all defenses based on the law of surety ship.

Demand, notice of default or of nonpayment are hereby waived and it is agreed that the said Landlord under the said Residential Lease may proceed first against the Guarantor(s) without first proceeding against the said Tenant under the said Residential Lease. If Landlord employs counsel to enforce this Guaranty, Guarantor(s) will reimburse Landlord for all attorney's fees, costs and expenses incurred. This Personal Guaranty shall be binding upon the heirs, administrators, executors and assigns of the undersigned Guarantors.
